## 1. General description

The 74HC1G02-Q100; 74HCT1G02-Q100 is a single 2-input NOR gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of

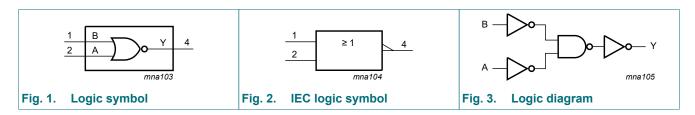

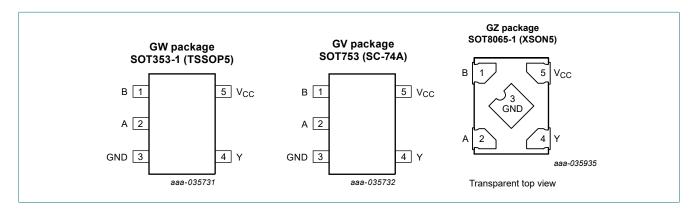

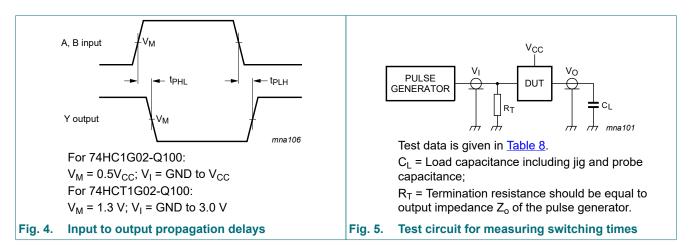

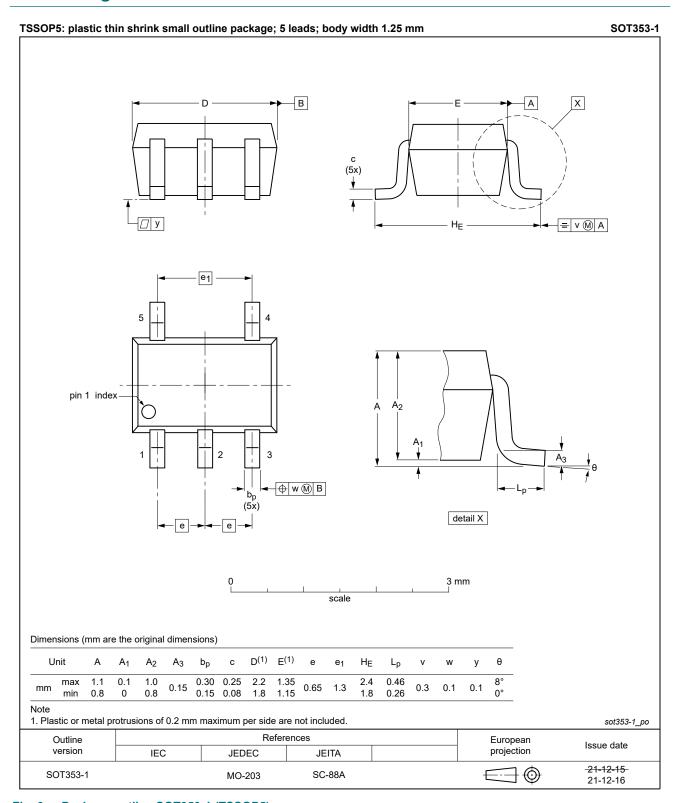


Fig. 6. Package outline SOT353-1 (TSSOP5)

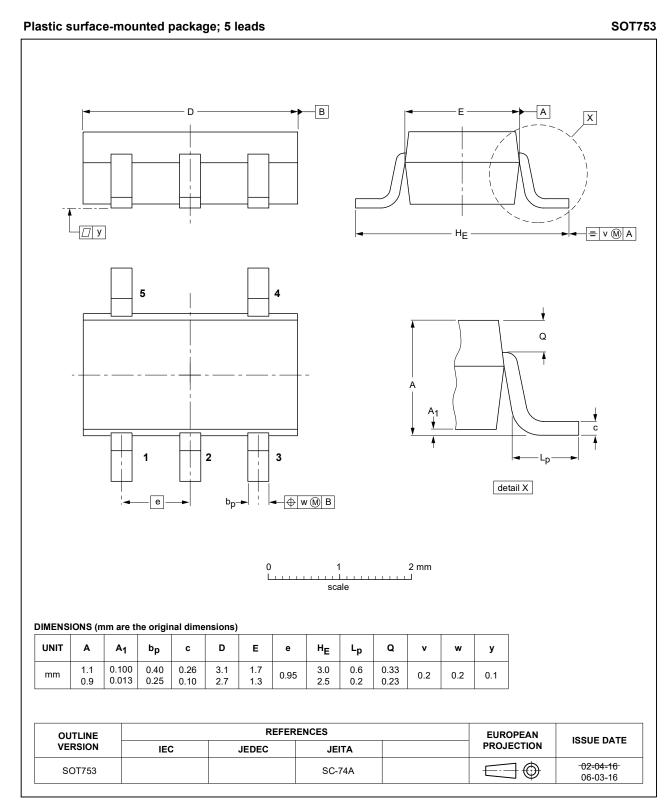


Fig. 7. Package outline SOT753 (SC-74A)

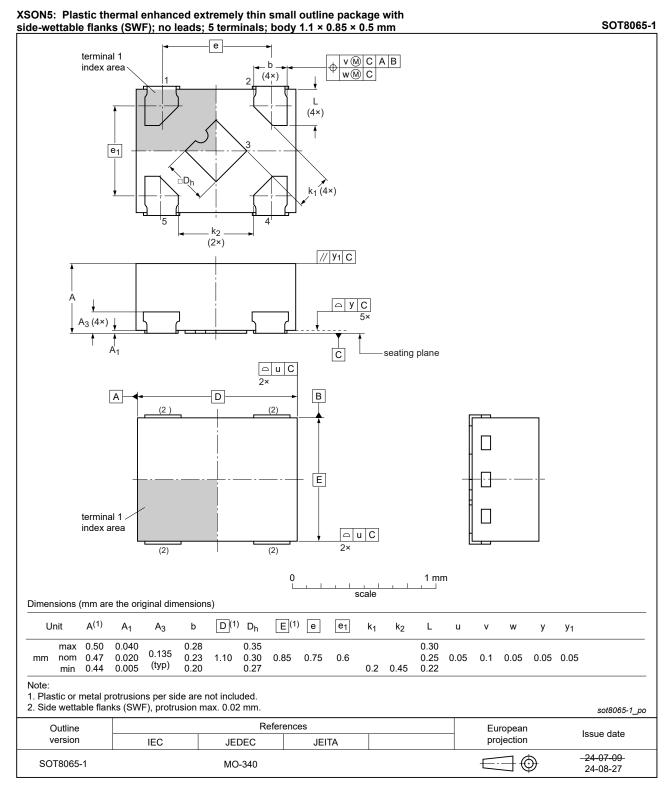


Fig. 8. Package outline SOT8065-1 (XSON5)
