1. General description

The 74LVC16240A is a 16-bit inverting buffer/line driver with 3-state outputs. The device can be used as four 4-bit buffers, two 8-bit buffers or one 16-bit buffer. The device features four output enables (10E, 20E, 30E and 40E), each controlling four of the 3-state outputs. A HIGH on noe causes the outputs to assume a high-impedance OFF-state.

Inputs can be driven from either 3.3 V or 5 V devices. When disabled, up to 5.5 V can be applied to the outputs. These features allow the use of these devices in mixed 3.3 V and 5 V applications.

This device is fully specified for partial power-down applications using I_{OFF} . The I_{OFF} circuitry disables the output, preventing the damaging backflow current through the device when it is powered down.




Fig. 2. IEC logic symbol








Fig. 5. 3-state enable and disable times




Fig. 7. Package outline SOT362-1 (TSSOP48)
