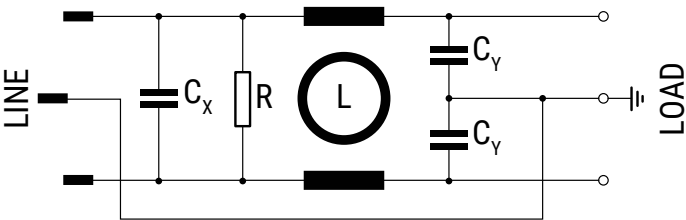

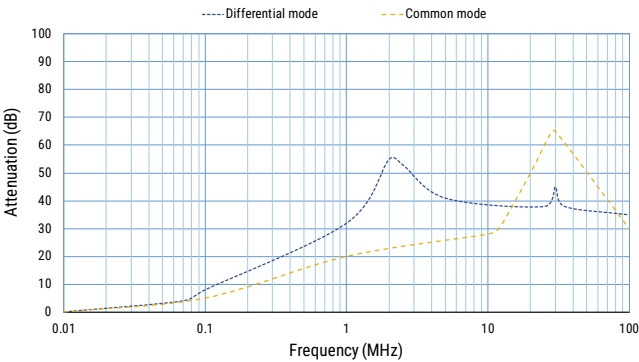
Typical Insertion Loss

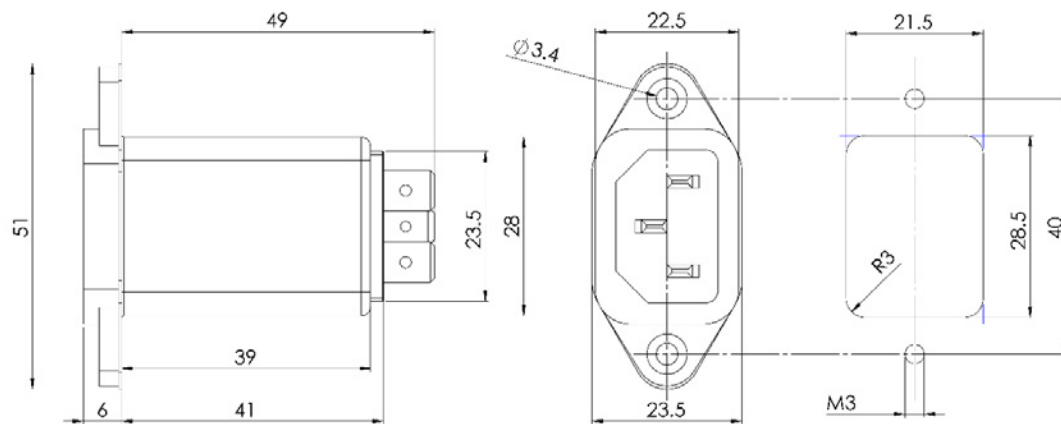
