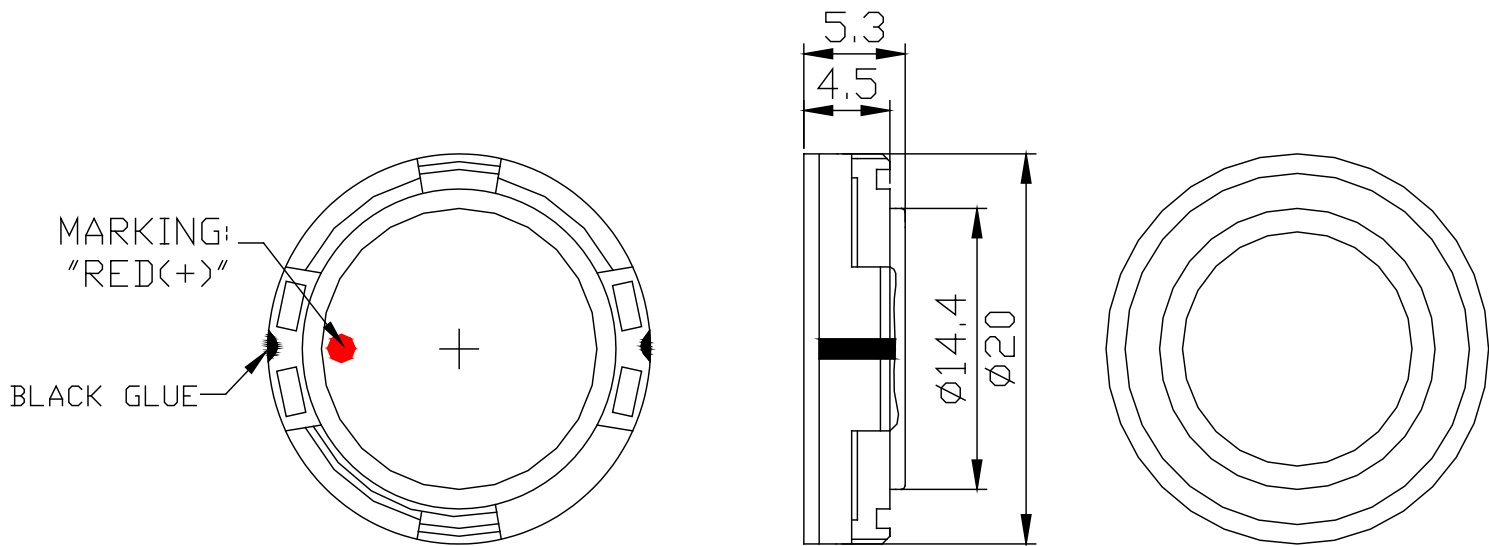

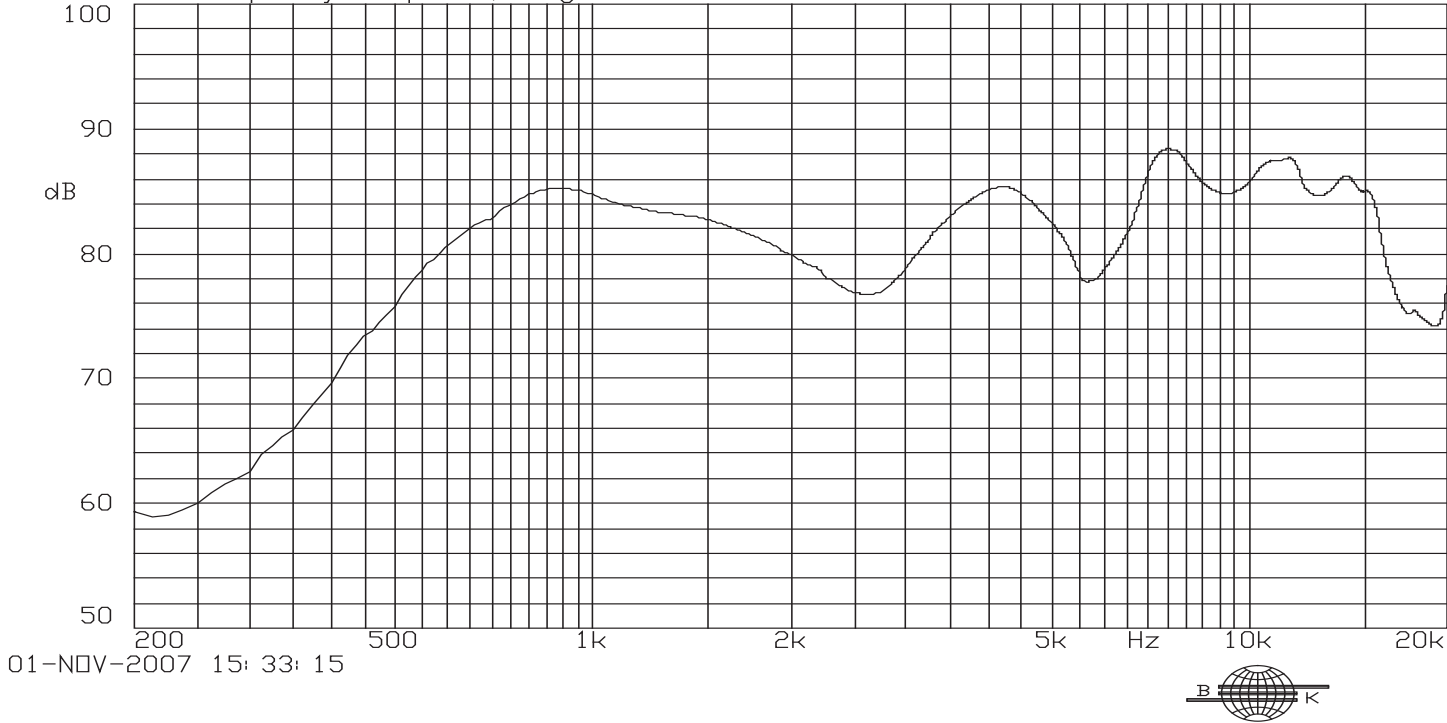


RESPONSE CURVES

Frequency Response Curve

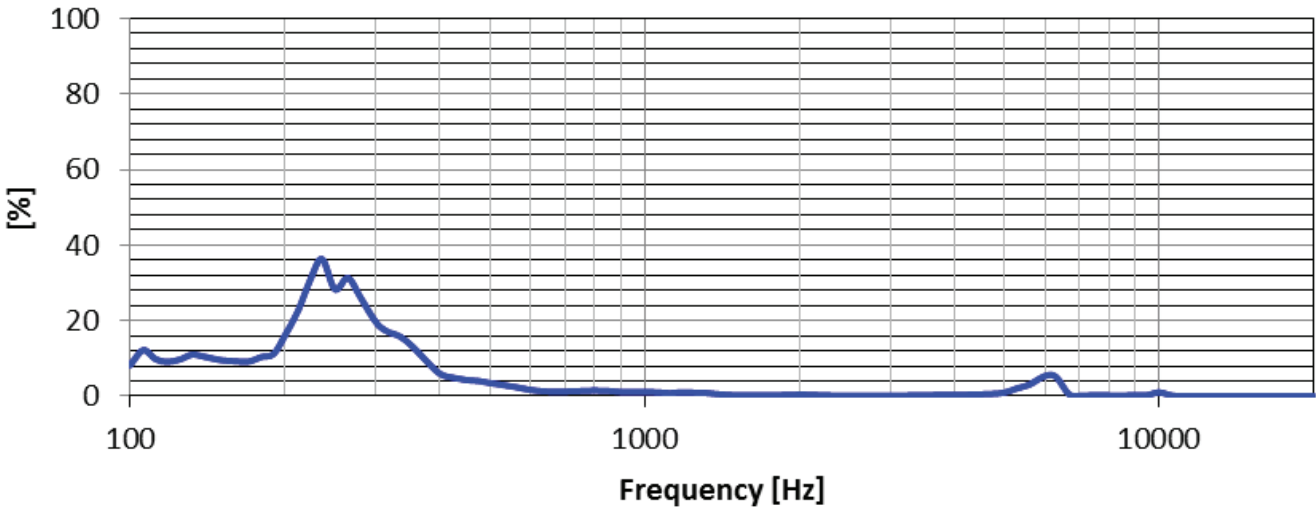
Test Conditions: 1.0 W / 0.5 m
