# Permissible Pulse Handling Capability



#### Tape and Reel <sup>9)</sup>





- <sup>3)</sup> Chromaticity coordinate groups: Chromaticity coordinates are measured during a current pulse of typically 25 ms, with an internal reproducibility of  $\pm 0.001$  and an expanded uncertainty of  $\pm 0.004$  (acc. to GUM with a coverage factor of k = 3).
