




Radiation Characteristics 6), 7)

 $I_{e,rel} = f(\phi)$






Relative Radiant Intensity 6), 7)


Max. Permissible Forward Current


Permissible Pulse Handling Capability






Component Location on Pad




Dry Packing Process and Materials 8)
