






#### Radiation Characteristics 8), 9)






#### Max. Permissible Forward Current







#### **Component Location on Pad**





## Dry Packing Process and Materials <sup>10)</sup>



Moisture-sensitive product is packed in a dry bag containing desiccant and a humidity card according JEDEC-STD-033.



#### **Notes**
