


Relative Spectral Emission 6), 7)


Radiation Characteristics 6), 7)

 $I_{e,rel} = f(\phi)$




Forward current 6), 7)

 $I_F = f(V_F)$; single pulse; $t_D = 100 \mu s$




Relative Radiant Intensity 6), 7)

 I_e/I_e (100mA) = f (I_F); single pulse; t_p = 100 μ s




Max. Permissible Forward Current

 $I_{F,max} = f(T_A); Rth_{ja} = 500K / W$




Permissible Pulse Handling Capability

 $I_F = f(t_p)$; D = parameter; $T_A = 25$ °C




Permissible Pulse Handling Capability





Notes
