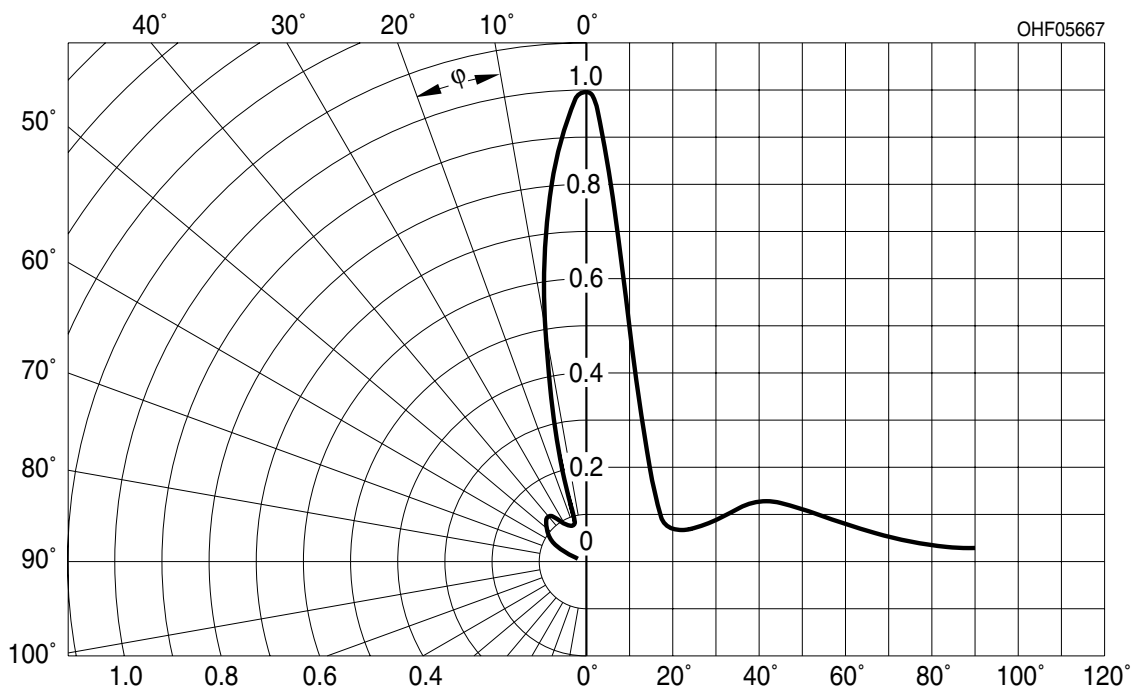

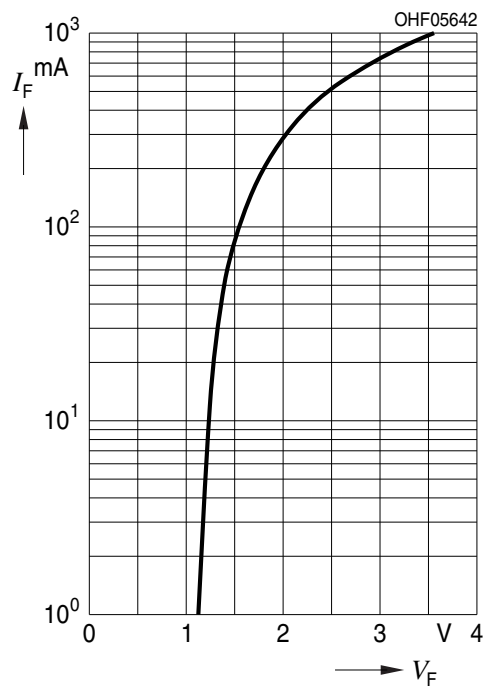

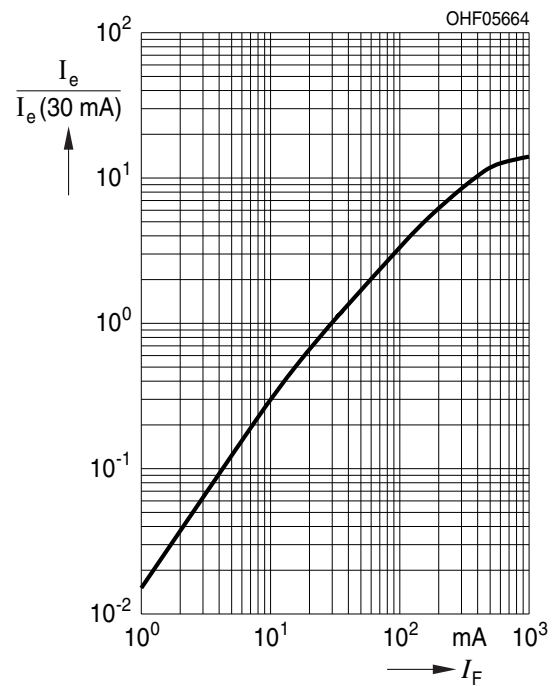

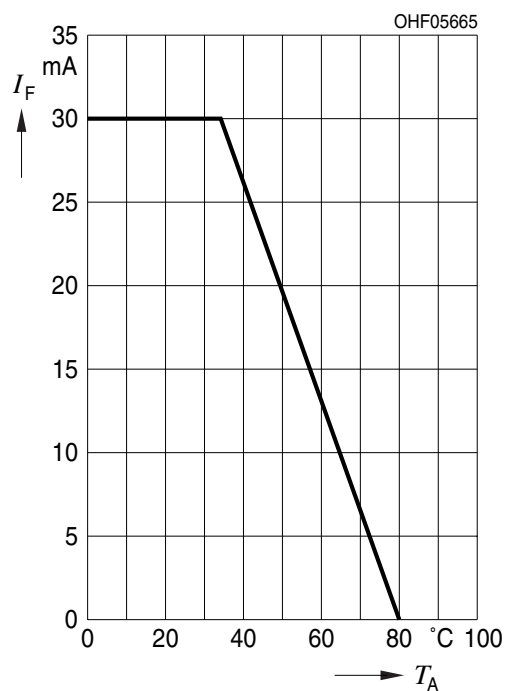
Relative Radiant Intensity ^{5), 6)}

$$I_e/I_e(30mA) = f(I_F); \text{ single pulse; } t_p = 100 \mu s$$



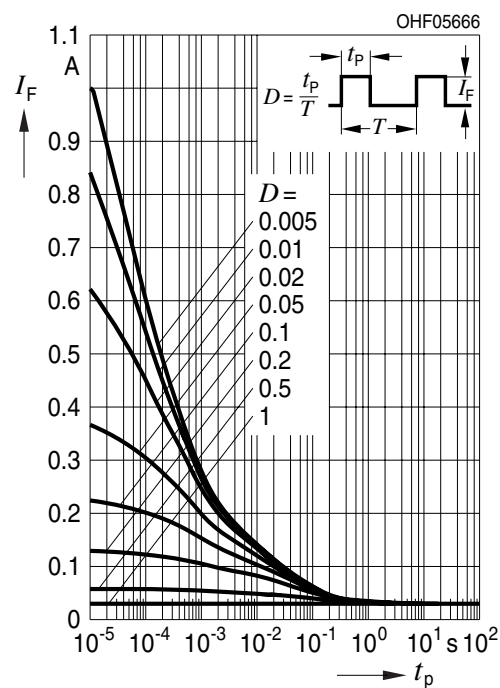
Max. Permissible Forward Current

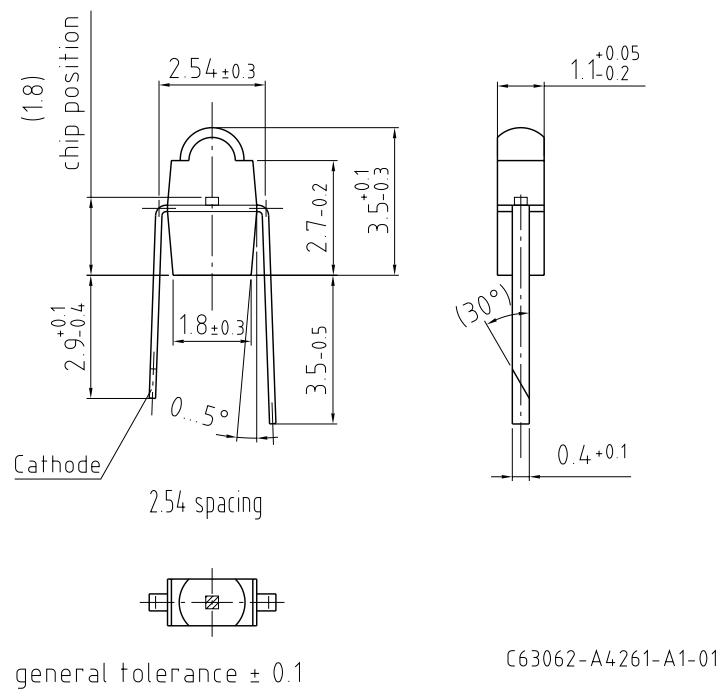


Permissible Pulse Handling Capability

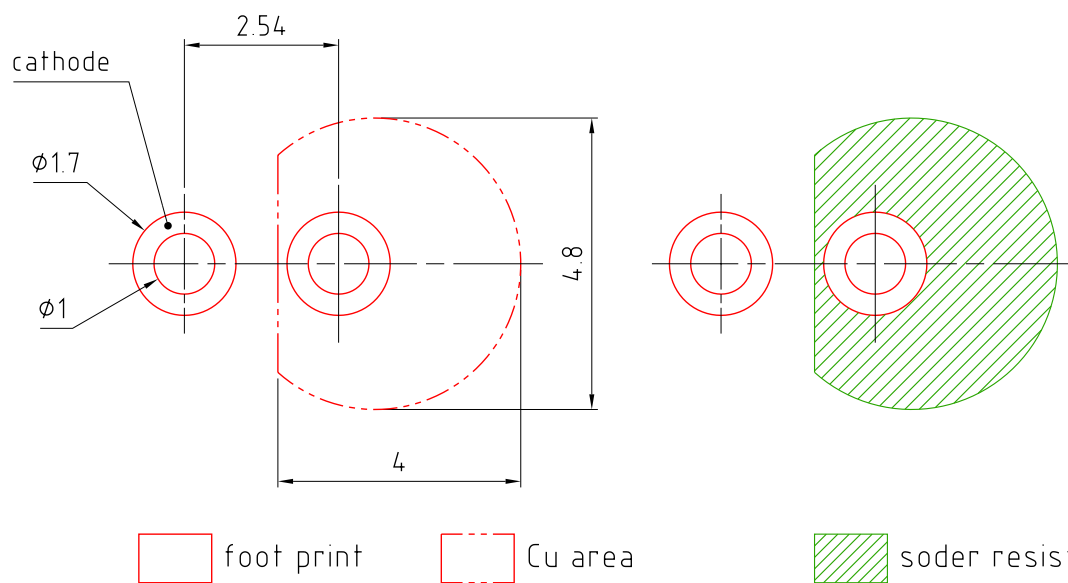
Dimensional Drawing ⁷⁾

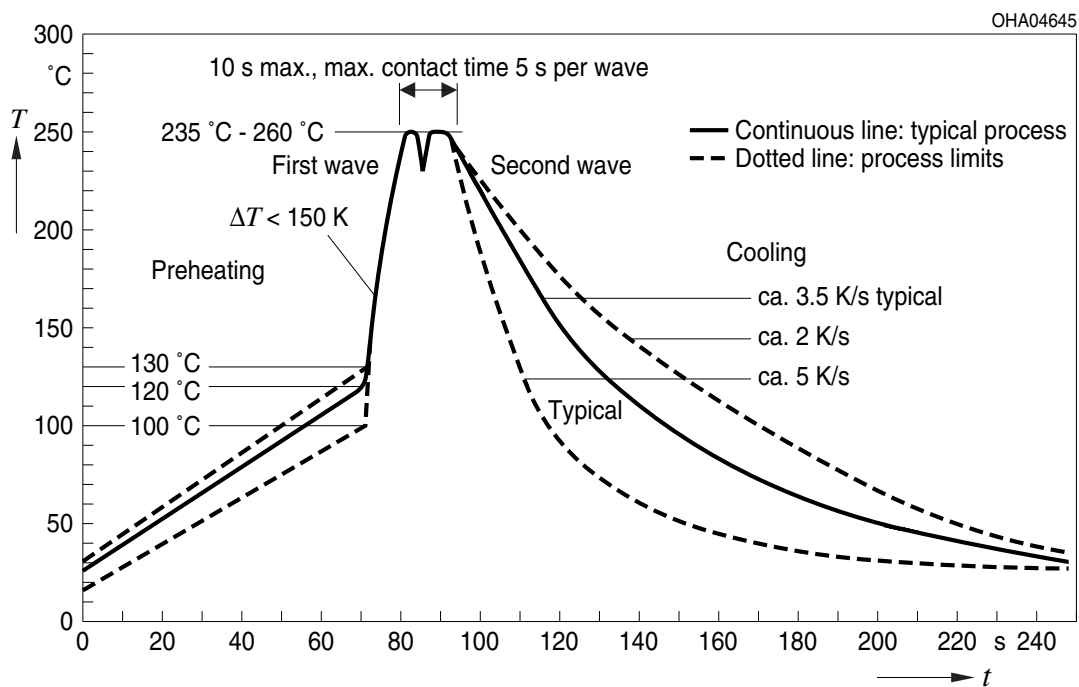

Notes

- 3) **Total radiant flux:** Measured with integrating sphere.
- 4) **Thermal resistance:** junction - soldering point, of the device only, mounted on an ideal heatsink (e.g. metal block)
- 5) **Typical Values:** Due to the special conditions of the manufacturing processes of semiconductor devices, the typical data or calculated correlations of technical parameters can only reflect statistical figures. These do not necessarily correspond to the actual parameters of each single product, which could differ from the typical data and calculated correlations or the typical characteristic line.
