


# Relative Spectral Emission 6), 7)


#### Radiation Characteristics 6), 7)

 $I_{e,rel} = f(\phi)$ 




#### Forward current 6), 7)

 $I_F = f(V_F)$ ; single pulse;  $t_D = 40 \mu s$ 




#### Relative Radiant Intensity 6), 7)

 $I_e/I_e(40\text{mA}) = f(I_e)$ ; single pulse;  $t_p = 40 \mu s$ 








## **Permissible Pulse Handling Capability**





#### **Notes**
