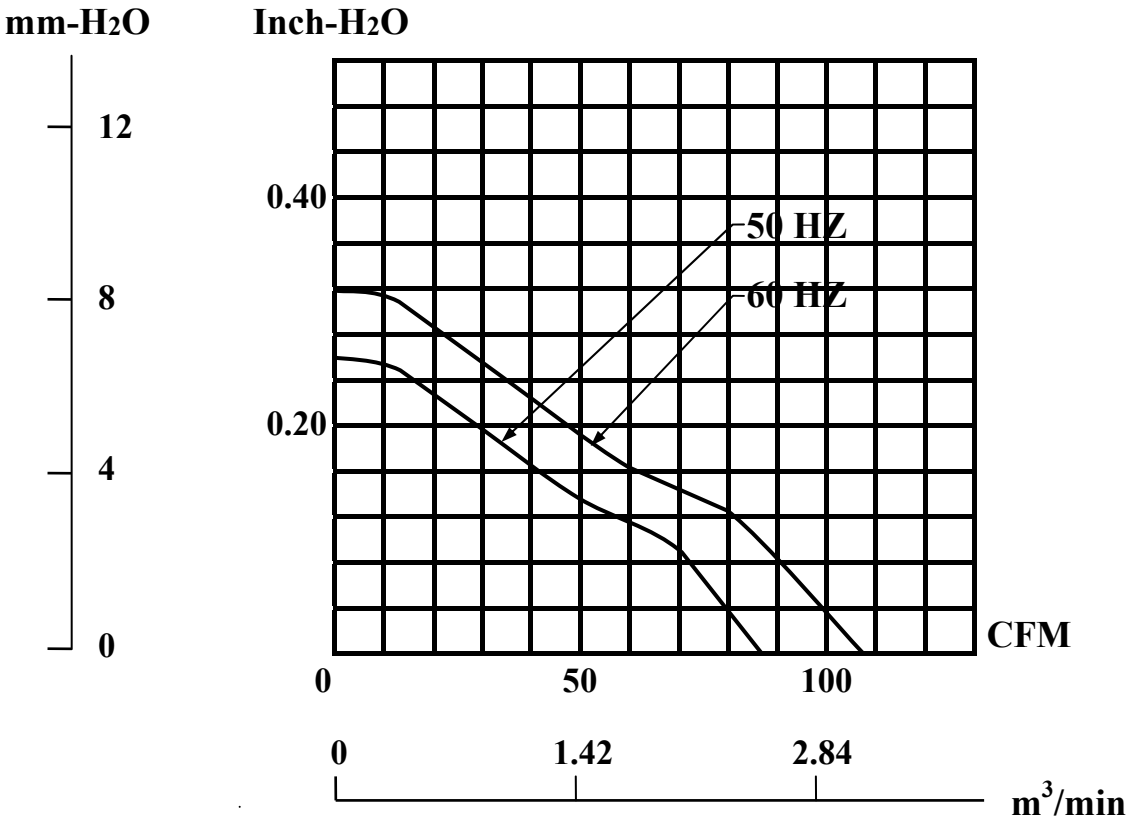

PRESSURE

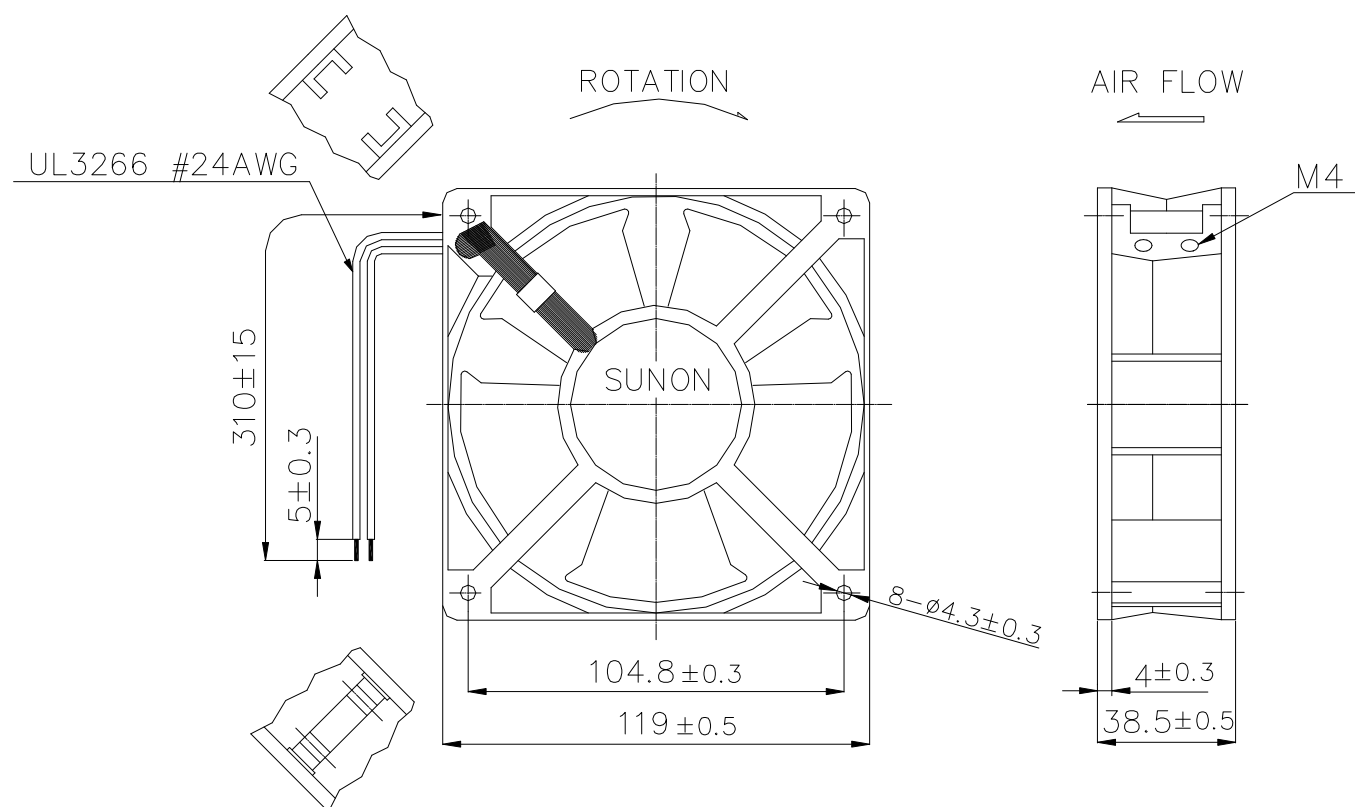
