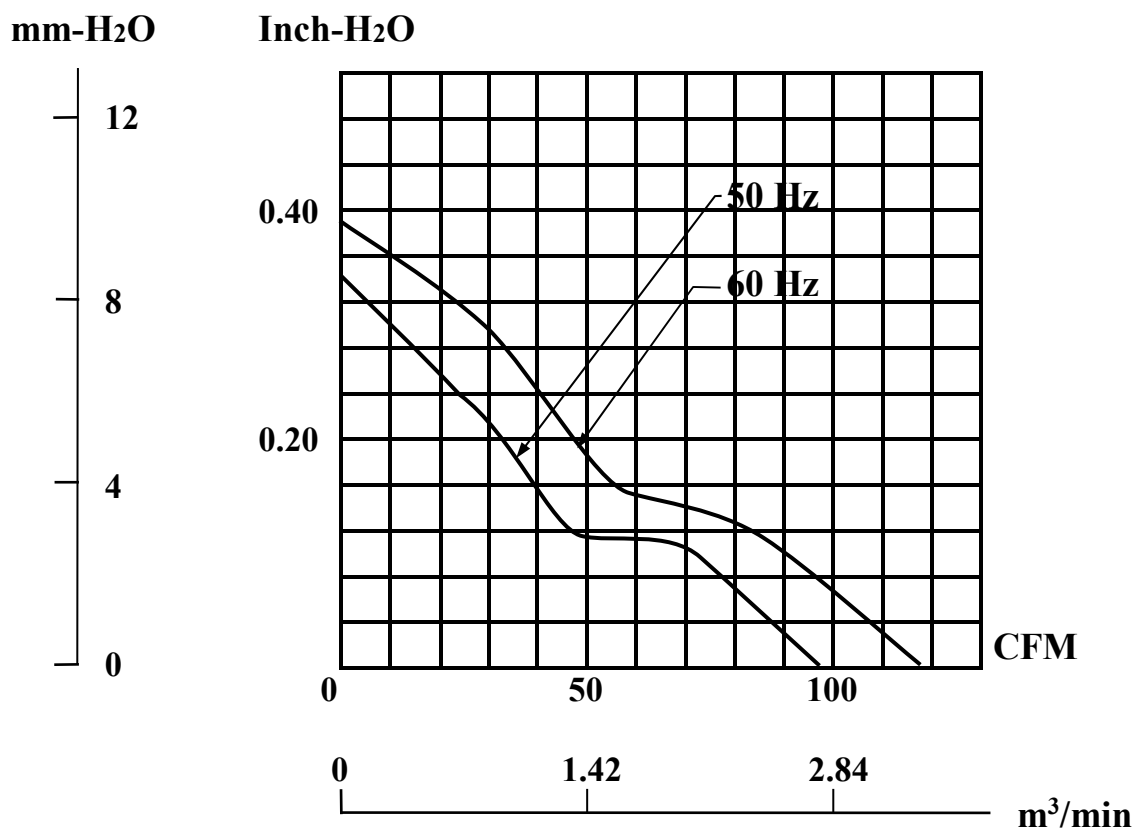

PRESSURE



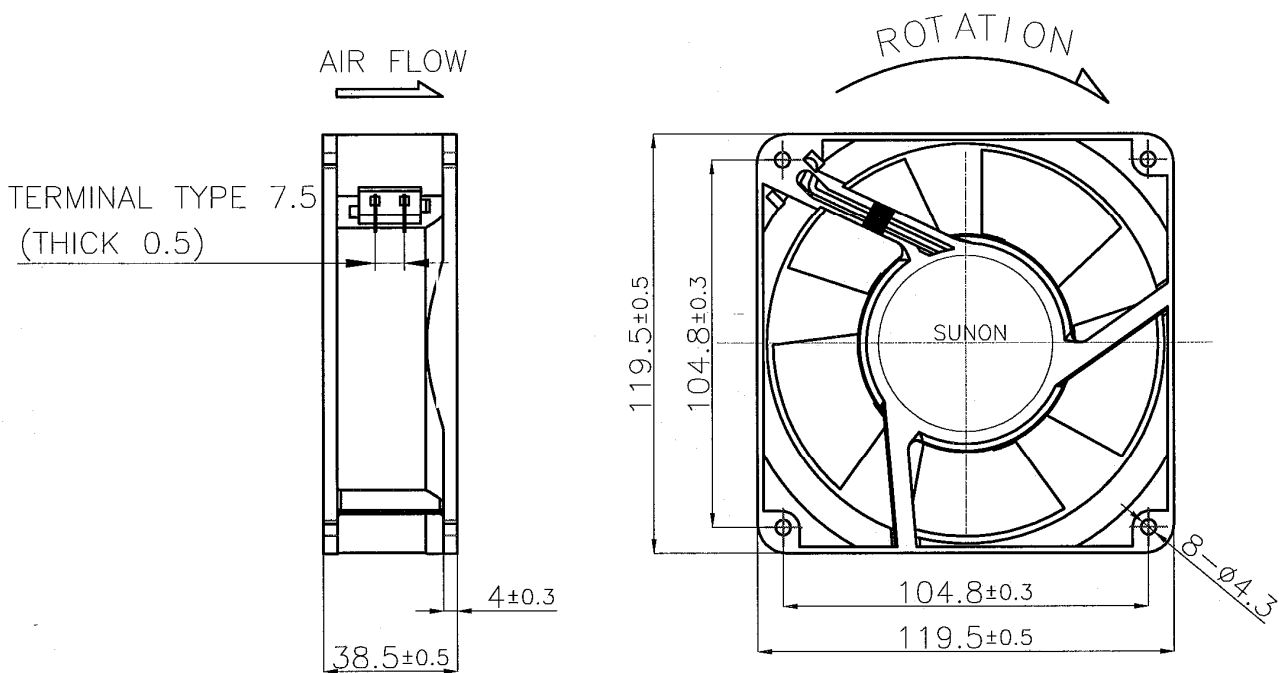
