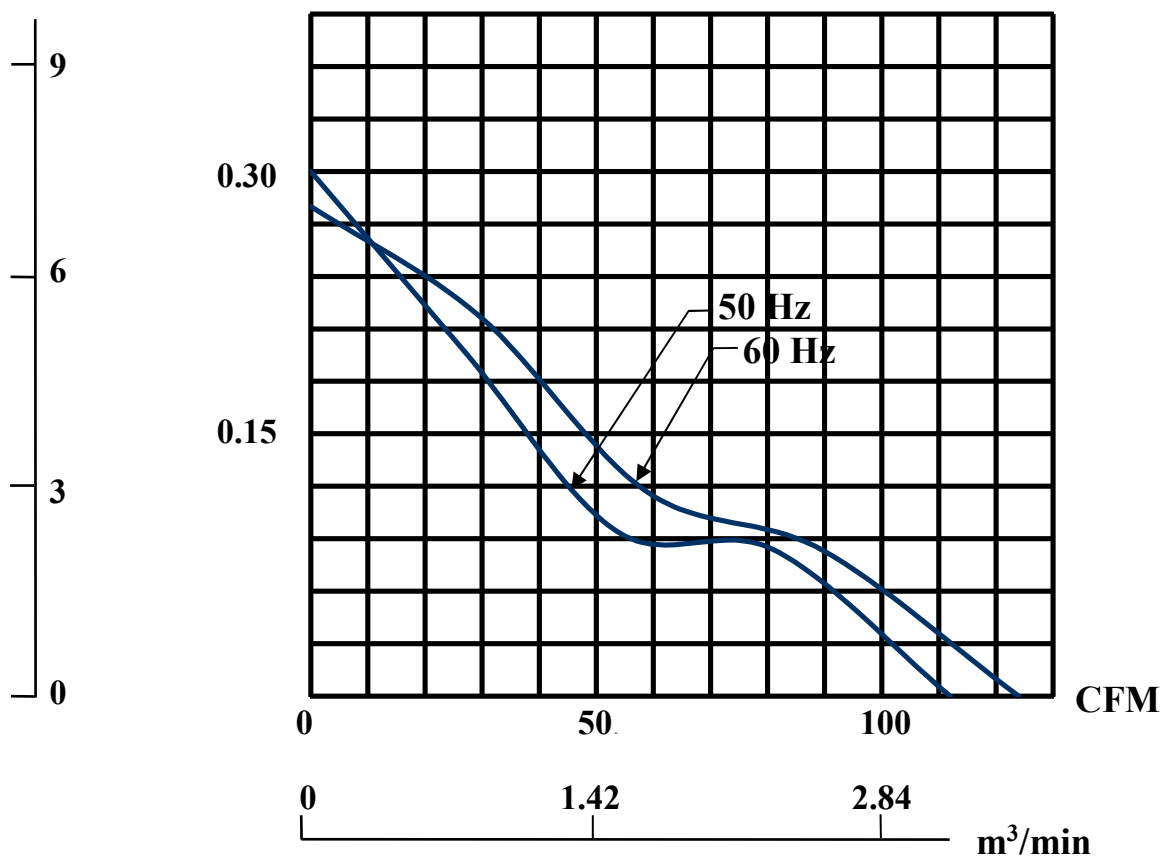

mm-H<sub>2</sub>O    Inch-H<sub>2</sub>O

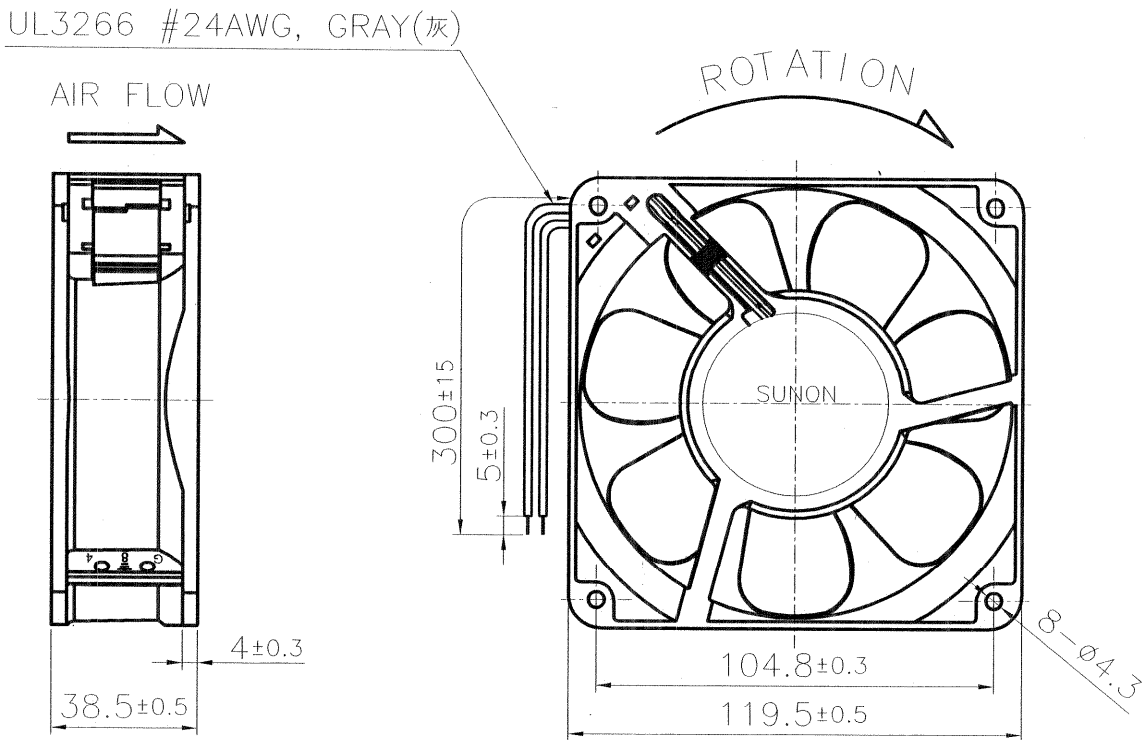
