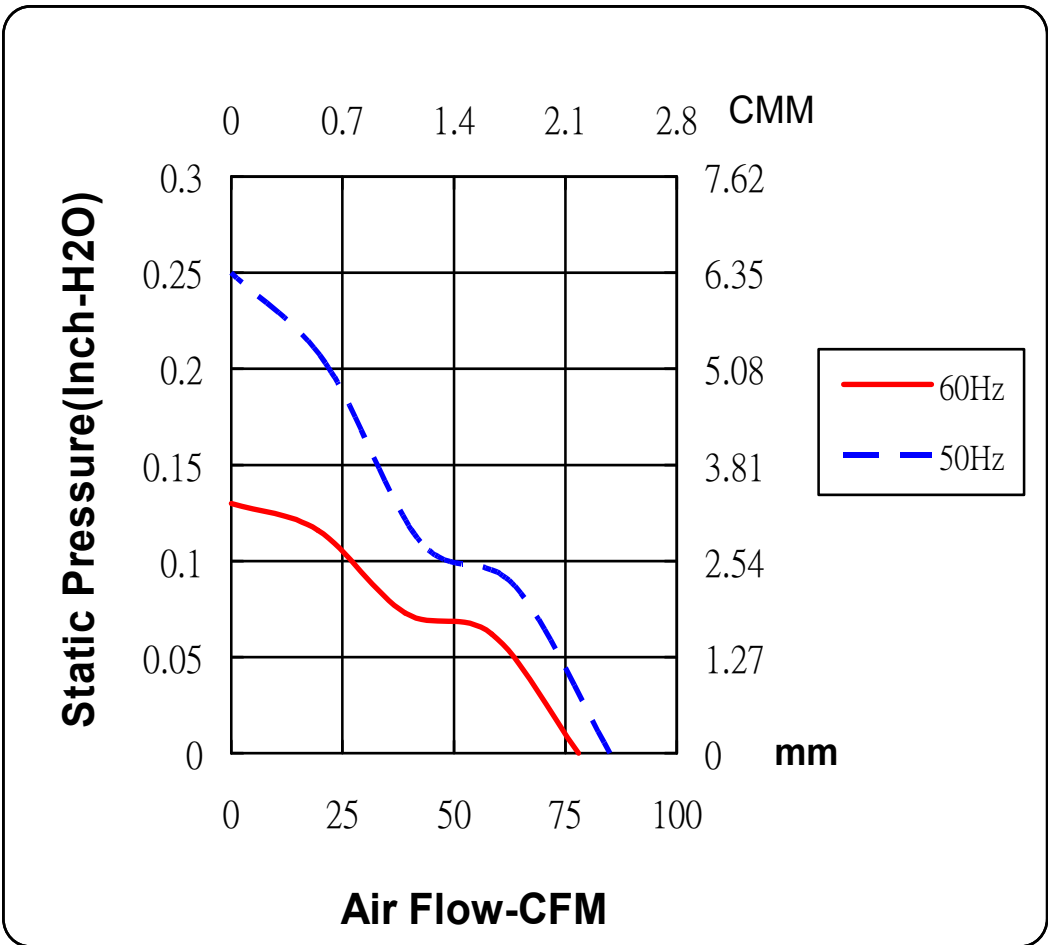

PERFORMANCE CURVES



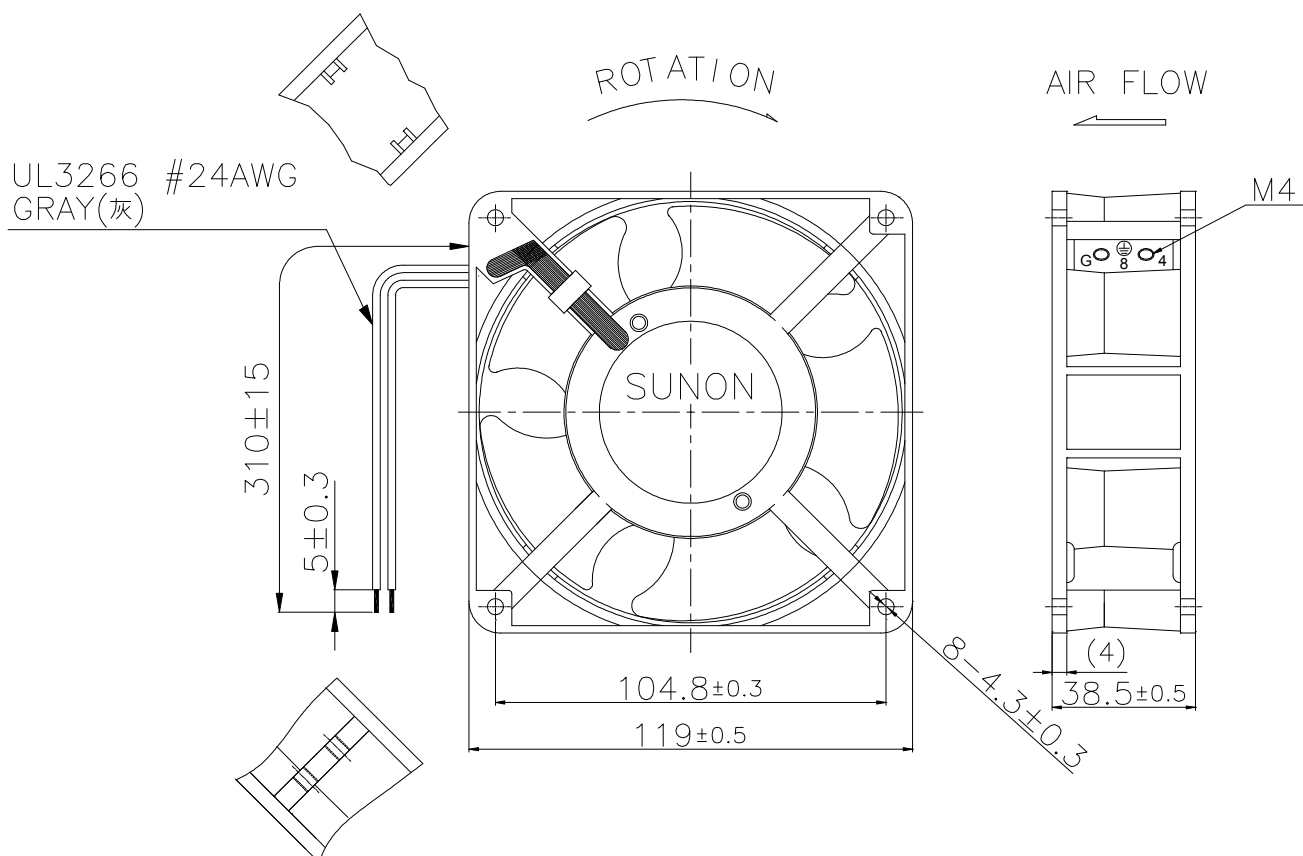
