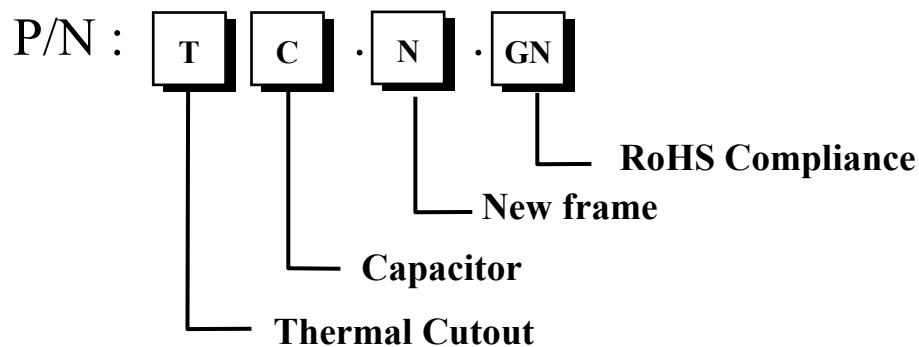
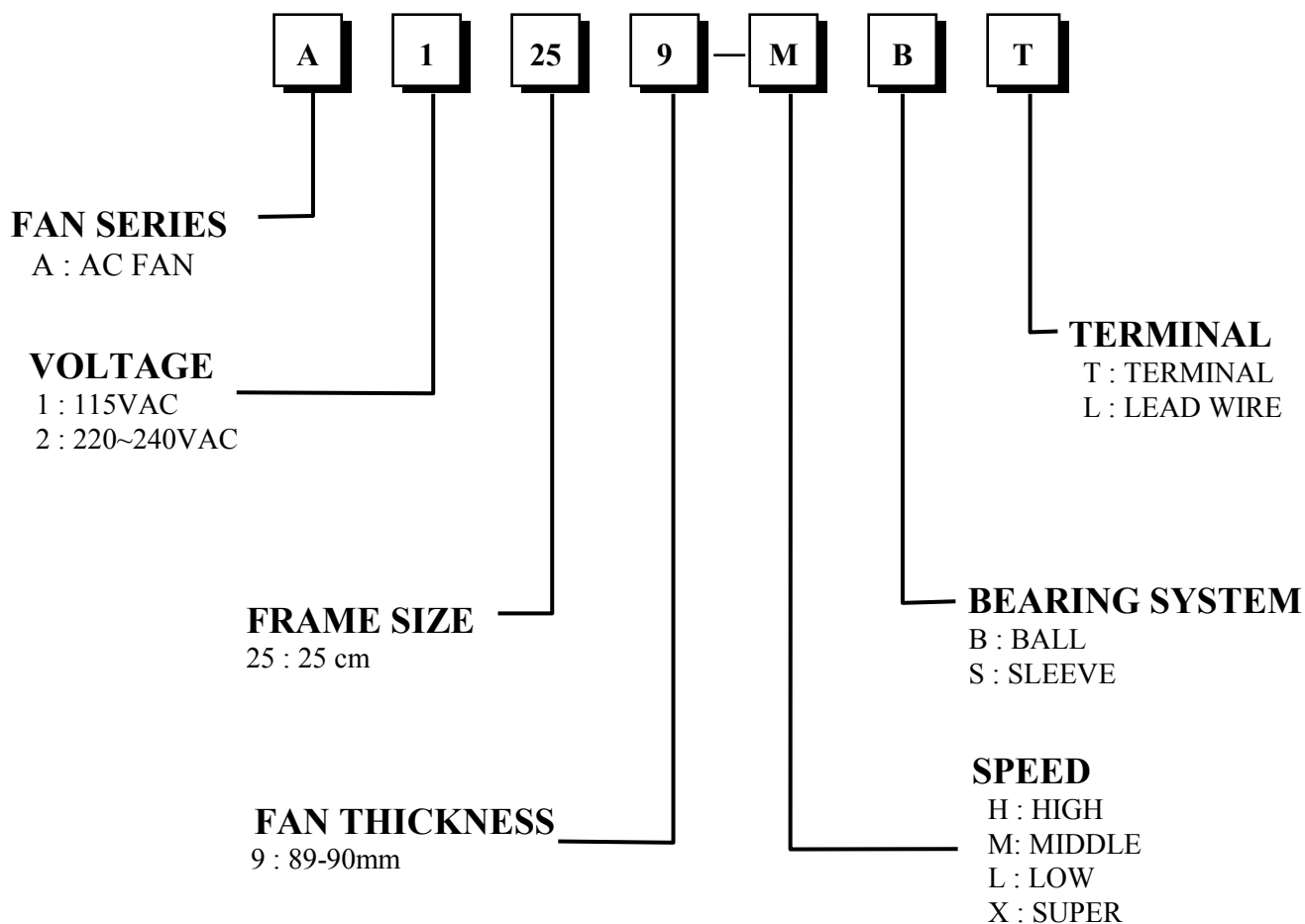

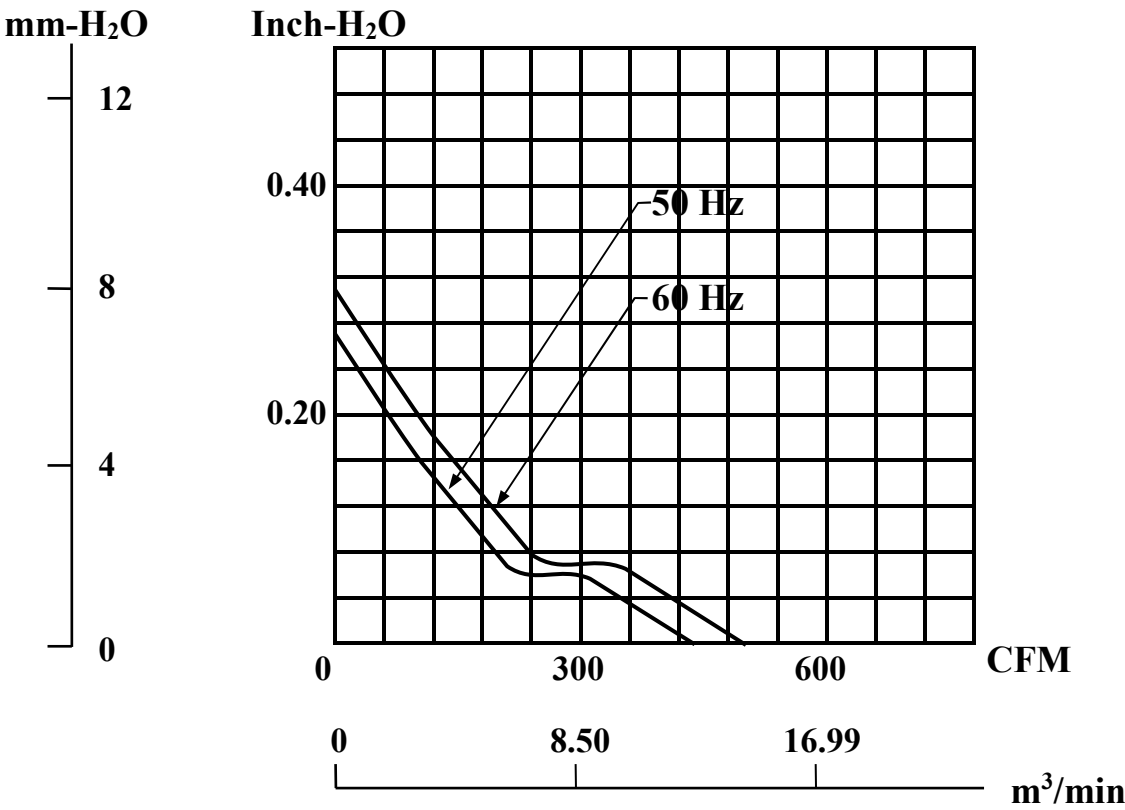

PRESSURE



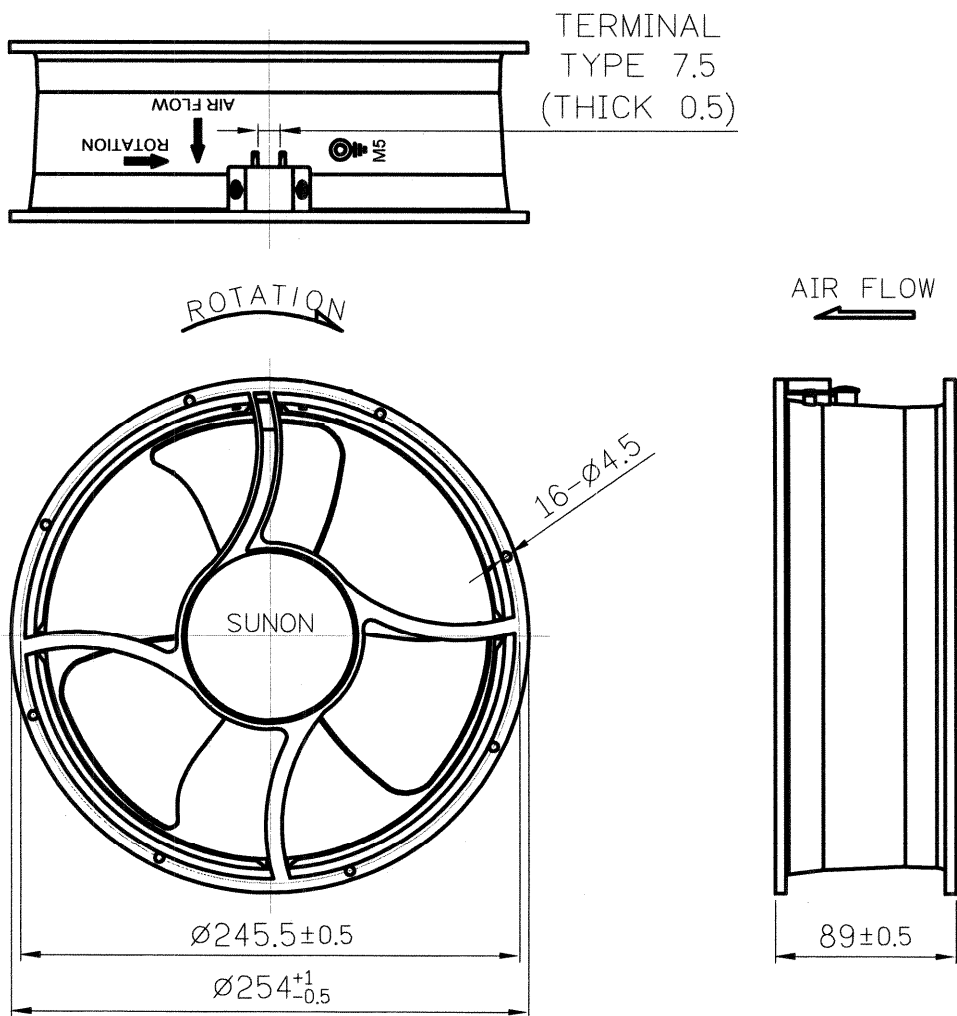

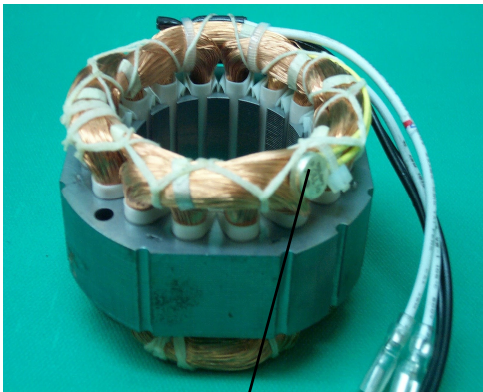
