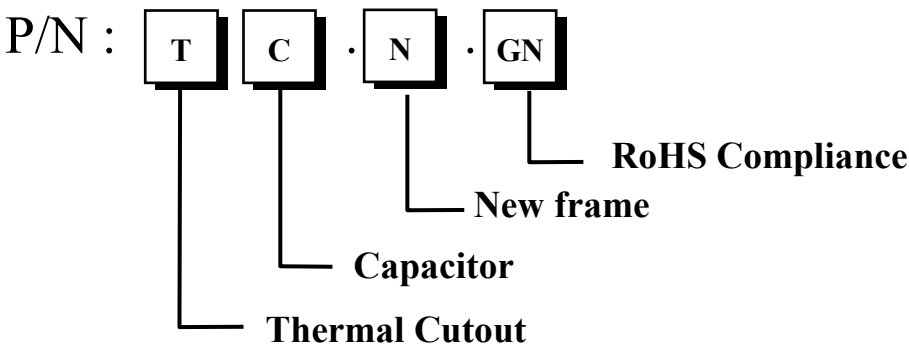
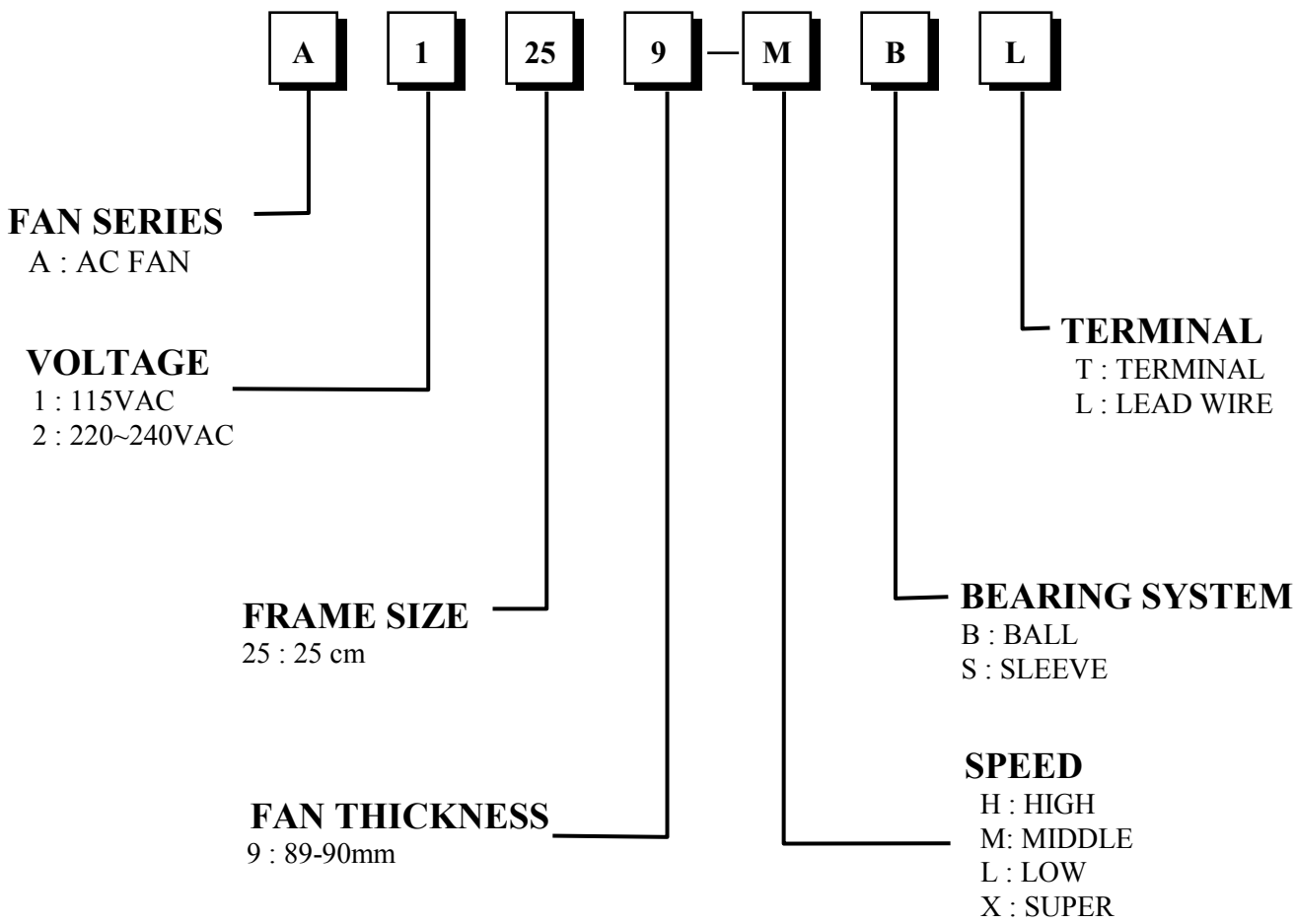

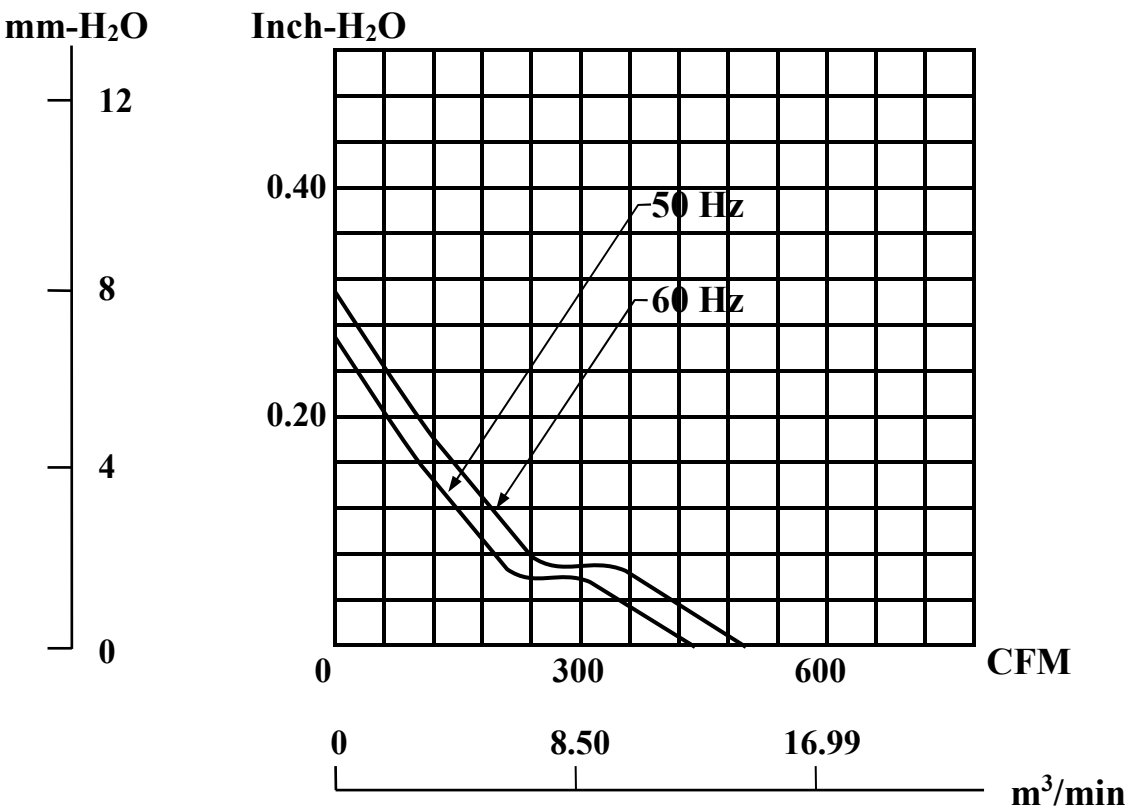

PRESSURE



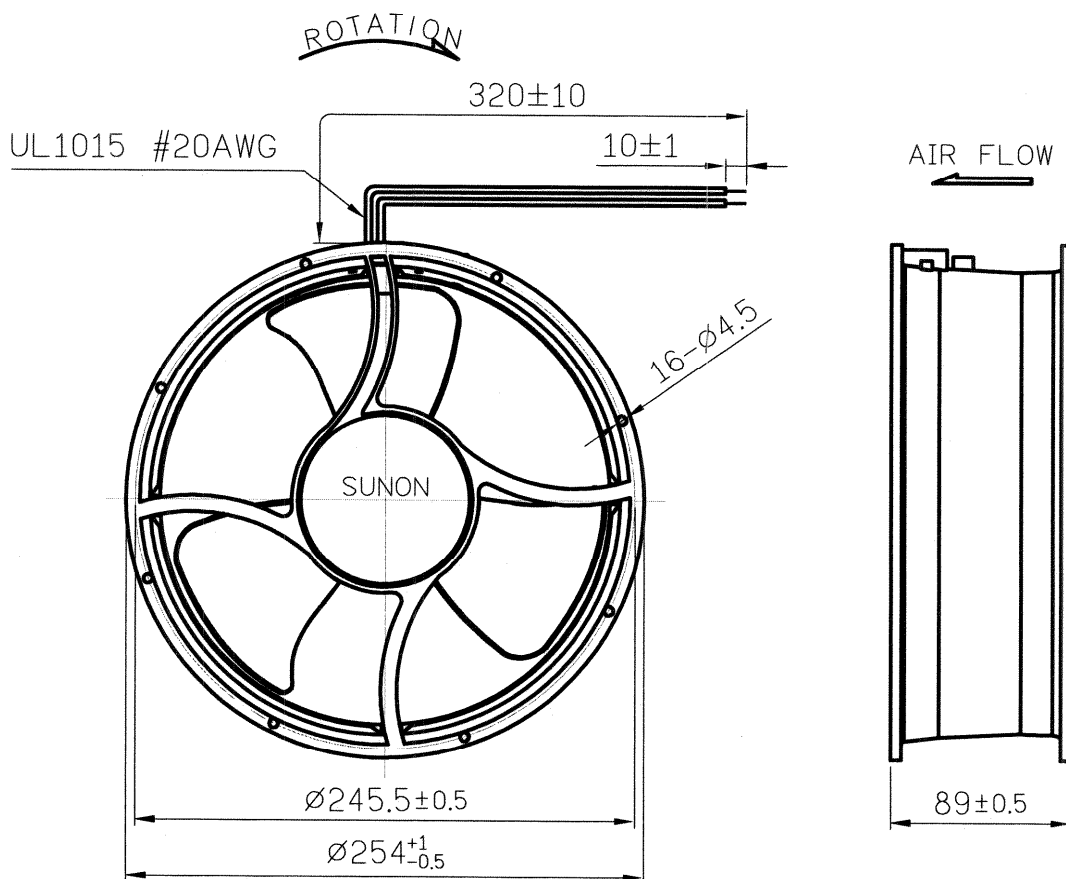

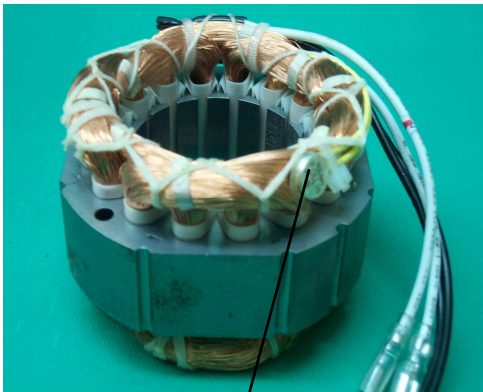

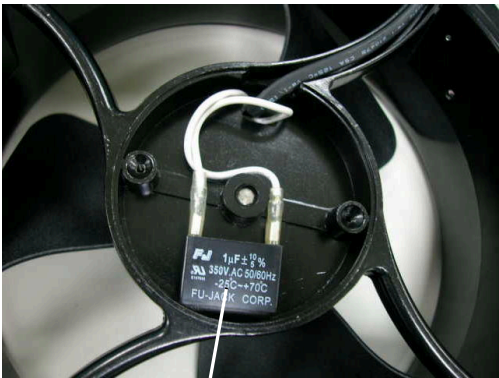
