


3rd Generation 600 V, 4 A Silicon Carbide Schottky

Description

In combination with the reduced cooling requirements and improved thermal performance of SiC products, SiC diodes are able to provide lower overall system costs in a variety of diverse applications.




Figure 1 Forward Characteristics




Figure 3Current Derating




Figure 5Total Capacitance Charge vs. Reverse Voltage




Figure 2Reverse Characteristics




Figure 4Power Derating




Figure 6Capacitance vs. Reverse Voltage




Figure 7Capacitance Stored Energy




Figure 9Transient Thermal Impedance





Figure 8Non-Repetitive Peak Forward Surge Current vs. Pulse Duraion


