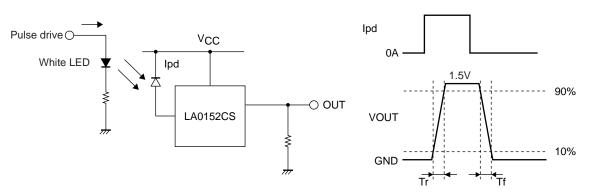

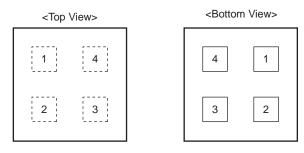

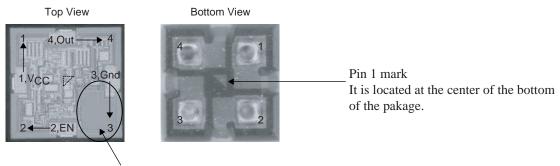

INTRNAL BLOCK DIAGRAM

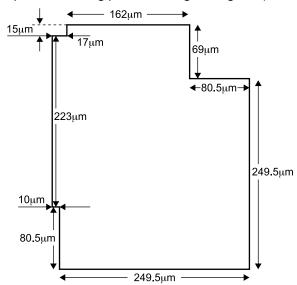


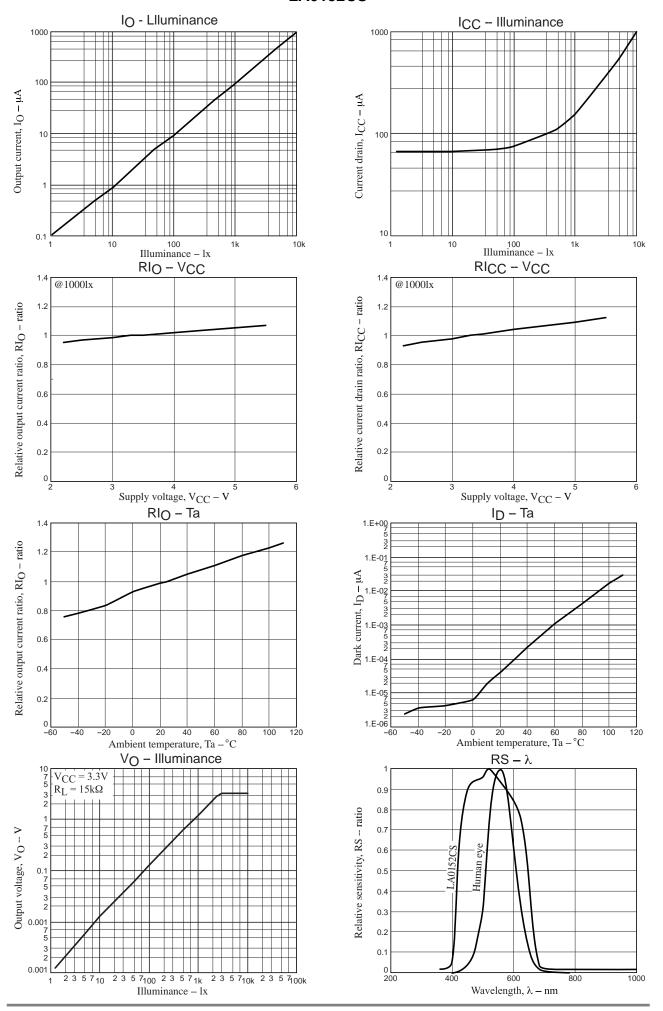

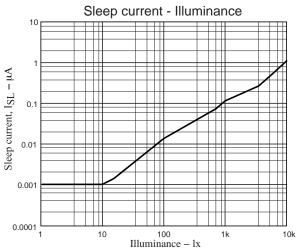
CHIP PATTERN AND PHOTO-RECEIVING PATTERN DIAGRAMS

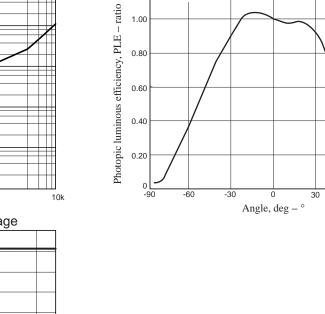


LA0152CS photo-receiving pattern enlarged diagram (effective area)



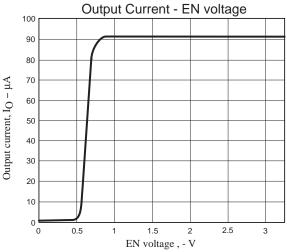

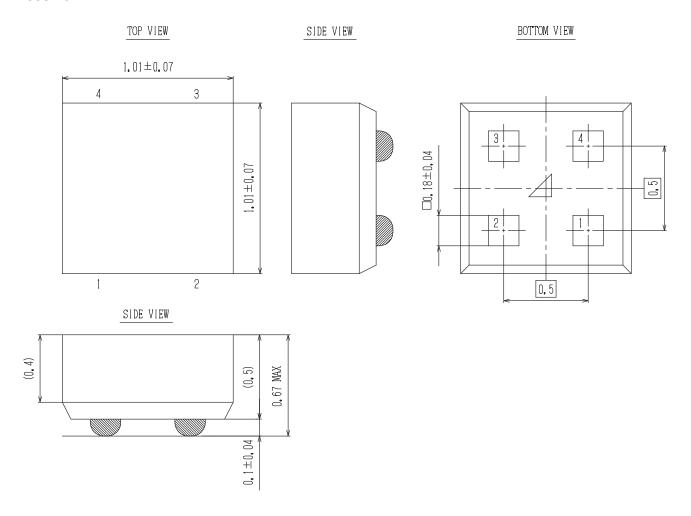
