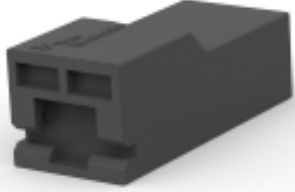


Crimp Terminal Housings(1)

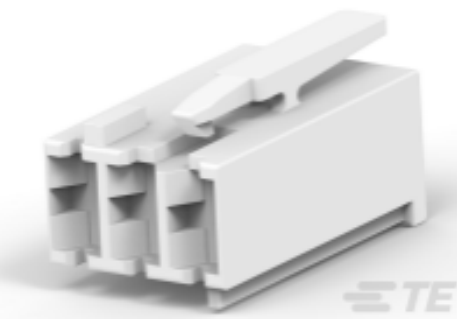
