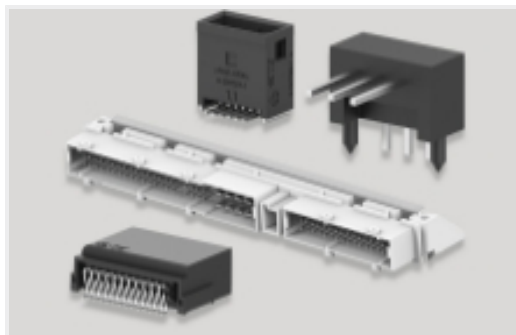
Backplane Connector Housings(19)

Hard Metric Backplane Connectors(1)

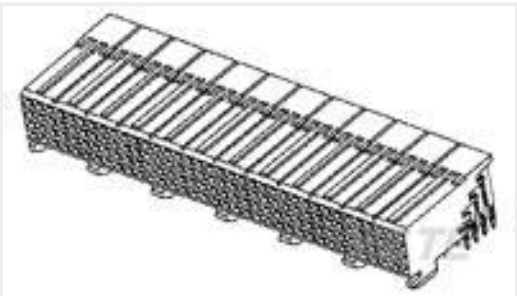


PCB Headers & Receptacles(14)
